This is with reference to school application on the subject cited above. I am directed to convey approval of the Board for Fresh Affiliation Up to Secondary Level as per details given below :

Sl. No.	The school is directed to ensure that :
1	The total number of sections for classes 1st to 10th shall be restricted to 27 only. The optimum number of the students shall be restricted to 40 in each section. Any further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of 500 sq ft and greater in dimension. The school is directed to run at least 01 section each of bal vatika I,II & III in accordance with the established norms permitted vide Board's circular no. 12/2023 dated 24.03.2023 and 25/2023 dated 11.09.2023.
2	The boundary wall at some places is not of appropriate height and seen less than 3 ft. whereas the school campus should be safe and covered with boundary wall of appropriate height (preferably 6ft) from all sides. School is directed to raise the height of the boundary wall covering the school campus from all sides for safety and security of the students and the staff. The compliance should be uploaded with videography within 03 month on SARAS portal.
3	The composite Science lab has not been properly arranged with the recommended safety measures as per the Board guidelines and SoPs. No fire extinguishers, exhaust fans, safety manual for users are available. Further, the cloth window curtain are note safe due to heating facility etc. School is directed to upgrade the lab as per circular No. 11/2022 and upload the compliance with videography within 03 months on SARAS portal.

4	The library has no proper sitting arrangements for the students and separate section for teachers/staff. Small chairs are not child age specific for proper upper secondary classes. Further, most of the library stock is reference and text books which needs to be enriched with recommended stock as per the Board guidelines vide circular No. 11/2022. School is directed to follow the Board guidelines and SoPs for library (circular No. 11/2022) and upload the compliance with videography within 03 months on SARAS portal.
5	The CWSN facilities and infrastructure has not been arranged as per the guidelines notified vide circular No. 05/2023 & 11/2024. Walkers have been temporarily placed in the CWSN toilets in place of proper commodes with side support/bars. Further, the CWSN facilities are not available at each floors. School is directed to follow the circular No. 11/2024 and upload the compliance with videography within 03 months on SARAS portal.
6	School is directed to make compliance of the Board guidelines vide circular No. Skill-75/2024 dated 23.08.2024 for composition of skill lab and upload the compliance within 03 months on SARAS portal.
7	The school shall ensure the training of its teachers with CoE, CBSE, Bengaluru and shall submit the compliance within 3 months on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
