- Shall follow language Policy as per Notification (Kannada Language Policy 2016).
- The school being governed by Government of Karnataka regulations for safety and security of students issued from time to time.
- The Management/School should submit/comply with CBSE affiliation norms and submit all the records and credentials accordingly.
- School recognition will be canceled in the event in case of breach of all the above said conditions as per RTE act 2009 and Karnataka Education Act 1983.

Regarding the above matter, the governing body of CARMEL JNANA EDUCATION TRUST, with DICE CODE NO. 29040105515, operates Mount Carmel School in Kadaganchi. The school holds recognition for providing English medium education from classes 1 to 8. Officials of the department reviewed the documents submitted with the renewal application and subsequently renewed the recognition as follows.

Conditions:

1. In accordance with the Child Rights Education Act of 2009 and the Karnataka Education Act of 1983 and under the rules made there, the school is registered and the accreditation is updated up to the class registered. Apart from these classes, no additional classes or sections are allowed.

The school is governed under the rules framed by the Karnataka Education Act of 1983 and the Child Rights Education Act of 2009.

The Child Rights to Education Act of 2009 stipulates that 25% of seats are reserved for children from weaker sections under the rules framed within it. The government possesses the authority to enroll students in the reserved seats under the RTE for schools covered by the act. The government has established regulations to facilitate the enrollment of children in neighboring schools where their parents reside. According to these regulations, if there are government-funded educational institutions available, children will be enrolled in those schools. Otherwise, private schools will admit students enrolled by the government and allow them to pursue their education up to the primary level. This system aims to ensure that these children can continue their education without facing discrimination.

4. The government has released the fees for children enrolled under RTE rules as described in Rule 3; hence it has stopped charging any fees from these children.
5. The school and its management are prohibited from collecting any kind of capitation fee or voluntary donations from parents either at the time of enrollment or later.
6. The school management body shall publish the information in the departmental website on the fees collected from the parents of the children in their school as tuition fees, as per State Government Notification No: ED:31:PGC:2019, dated 27.07.2019, and also on the school notice board. No fee shall be charged in excess of the prescribed amount.
7. The school / governing body shall enroll the students only within the period set by the government.
8. The school/governing body cannot refuse enrollment based on the following factors.
 - (i) Due to lack of proof of age,
 - (ii) Based on caste, religion, place of birth, and language,
 - (iii) If admission is sought after the extended admission period,
9. Carrying out all safety measures as per the RTE Act and Rules, the Karnataka Education Act and Rules, [including obtaining fire safety and building safety certificates from the concerned authorities] as well as ensuring child learning safety in accordance with the K.S.C.P.C.R and N.C.P.C.R.
10. The School / Governing Body is as follows,

- i. No child admitted to school, until completion of primary or secondary education in any class, should be held back or expelled.
No child should endure physical or mental abuse.
No child is required to pass any board examination until the completion of primary education.
Every child who completes primary education under RTE Rule 21 and the Karnataka Education Act and Rules will be issued a certificate as prescribed.
As per the provisions of the RTE Act and Rules, as well as the Karnataka Education Act and Rules, the school should include children with special needs.
According to the RTE Act, Rules, Karnataka Education Act, Rules, and Government Orders, primary and high school teachers must possess the minimum qualifications as prescribed.
Salary and allowances payable to teachers, as well as the terms and conditions of service, shall be as prescribed by the State Government. Salaries are paid to teachers through government notification, Provident Fund (PF), and other salaries payable through banks. These payments are subject to the Employee State Insurance (ESI).
- viii. Teachers shall perform the duties prescribed under Section 24[1] of the Teachers Act, the RTE Act and Rules, and Rule 17 of the Karnataka Education Act and Rules, and shall not engage themselves in private tuitions for supervisory considerations.

11. Following the academic state curriculum and state textbooks with which the school is affiliated.
12. The school shall maintain rules and standards as specified in Section 19 of the Karnataka Education Act, appoint departmental staff as prescribed in the rules.
13. School buildings and other school-related infrastructure should not be used for any commercial activities, day or night, nor should they be allocated for political or non-academic activities.
14. The school should not be run for the benefit of any individual, group, or association.
15. Ensure that the school is audited by a Chartered Accountant and submit a copy of the audit report to the Director/Field Education Officer by the end of June every year.

22. In the event of a violation of the above conditions, as per the rules outlined in the RTE Act 2009 and the Karnataka Education Act 1983, the school's accreditation will be revoked.
